Nevertheless, Dworkin's failure usefully points to two problems in Hart's version of the rule of recognition: that it lacks a suitable restriction on the scope of the rule's possible content and the rule's own normativity is inadequately explained. -- I then examine a proposal for amendment according to which the rule of recognition is to take a non-conventional. I argue that this amended understanding is false and the only viable option is to take a non-conventionalist approach and interpret the content of the rule of recognition as excluding moral considerations. There are

indeed some false elements in Hart's original idea. However, it remains a powerful explanatory device if equipped with the right modifications in response to criticism. It is not a myth.
