Starting with the premise that most violence is the result of real or perceived scarce resources, Avalos persuasively argues that religion creates new scarcities on the basis of unverifiable or illusory criteria. Through a careful analysis of the fundamental texts of Judaism, Christianity, Islam, and Hinduism, Dr. Avalos explains how four scarce resources have figured repeatedly in creating religious violence: sacred space (e.g., the perception by three world religions that Jerusalem is sacred); the creation of holy scriptures (believed

to be privileged revelations of God's will); group privilege (stemming from such beliefs as a chosen people or predestination, which also creates a group of outsiders); and salvation (by which concept some are accepted and others rejected). Thus, Avalos shows, religious violence is often the most unnecessary violence of all since the scarce resources over which religious conflicts ensue are not actually scarce or need not be scarce. Comparing violence in religious and nonreligious contexts, Avalos makes the compelling argument that if we condemn violence caused by scarce resources as morally objectionable, then we must consider even more objectionable violence provoked by alleged scarcities that cannot be proven to exist. He also examines the Nazi Holocaust and the Stalinist Terror, which have been attributed to the pernicious effects of atheism or secular humanism. By contrast, Avalos pinpoints underlying religious factors as the cause of these horrific instances of genocidal violence. This serious philosophical examination of the roots of religious violence adds much to our understanding of a perennial source of widespread human suffering. Hector Avalos (Ames, IA) is associate professor of Religious Studies at Iowa State University, the author of five books on biblical studies and religion, the former editor of the *Journal for the Critical Study of Religion*, and executive director of the Committee for the Scientific Examination of Religion.

Julius Streicher - Tainted Images, Stolen Lives John J. Michalczyk, 2025-11-03 In Leni Riefenstahl's propaganda film of 1934 Nazi Party Rally in Nuremberg (*Triumph of the Will*), Julius Streicher proclaims: "A people which does not hold with the purity of its race will perish!" This belief will consume Streicher's life until his death on the gallows in 1946. Streicher, a devoted disciple of Hitler from 1923 at the time of the aborted Beer Hall Putsch, held some of the most anti-Semitic beliefs of the Nazi Party. After Dr. Joseph Goebbels, Minister of Propaganda and Public Enlightenment, Streicher became perhaps the next highly established propagandist in the Nazi Party, although berated for his crude and simplistic means of spreading the hatred of Jews. In his diary, Joseph Goebbels himself decried Streicher's outlandish caricatures. From 1923 to 1945, Streicher published his infamous anti-Semitic weekly newspaper *Der Stürmer*. The newspaper, filled with vulgar stereotypes of Jews, at times bordering on the semi-pornographic, emanated from Julius Streicher's publishing house and was read religiously in the popular display cases throughout Germany. In 1936, following the pedagogical guidelines of "education" of children in the Nazi ideology, Streicher's publishing house originated and distributed three anti-Semitic children's books: *Trust No Fox on His Green Heath* and *No Jew on His Oath*, *The Poisonous Mushroom* and *The Mongrel*. The propagandistic goal of the books was to teach children at an early age to hate Jews, seen as the scourge of the German Aryan population. A detailed analysis of the images by various illustrators such as Willi Hofmann and Philipp Rupprecht (Fips) reveal the Jew as "The Other", which helped reinforce the hatred of Jews, leading to the tragedy of the Holocaust.

*In Truth* Matthew Fraser, 2020-03-27 From ancient Rome to the current Internet age, this sweeping history of ideas explores how different epochs wrestled with the issue of truth and lies. By the time he had completed his first year as the chancellor of the Germany Mein Kampf had become an essential component of German social life. People are using the then Legendary book Mein Kampf for gifts, homage, education and for whatever, whenever possible. And by the time the WORLD WAR II ended the sales of Mein Kampf in Germany alone was toughing 10 Million mark. The book was running in top selling list for over a decade competing neck to neck and sometimes lagging behind the Bible. Writing a book to disseminate his ideas concerning Nazism or Fascism had been important for Adolf Hitler until he finally reached his goal of Chancellorship. However, when the first book of two volumes, could not help him much in gaining ground in German politics he wrote his next book that was never published. Later in his last years, when the war was about to end, Adolf Hitler ordered his comrades to put the original manuscript in a locker under a shelter for Air Strikes. This book was an extension of NAZI viewpoints, ideas and propaganda. Hitler used his energy to further improve the NAZI ideology and engineer new components and enhance the former ones.
